(TRADEMARK)

THIS RELEASE (TRADEMARK) is given as of this 31<sup>st</sup> day of October, 2000 by the Chase Manhattan Bank, with principal offices at 380 Madison Avenue, 9<sup>th</sup> Floor, New York, New York, 10017, ("Assignor"), to Recoton Corporation, Christie Design Corporation, Interact Accessories, Inc., Recoton Audio Corporation, ReCone, Inc., Recoton Home Audio, Inc., Recoton Japan, Inc., Recoton International Holdings, Inc., Recoton European Holdings, Inc., and AAMP of Florida, Inc., (collectively "Assignees"), as follows:

WHEREAS, Assignor and Assignees entered into a certain collateral Agreement, dated as of September 8, 1999 (the "Collateral Agreement"), pursuant to which Assignees granted to Assignor, a first priority security interest, a second priority interest, and a third priority security interest in the Collateral (as defined in the Collateral Agreement), to secure the prompt and complete payment and performance of the First Priority Obligations, Second Priority Obligations, and Third Priority Obligations, respectively (as defined in the Collateral Agreement and collectively referred to therein as the "Secured Obligations").

WHEREAS, pursuant to the Collateral Agreement, Assignor and Assignees entered into a certain Trademark Security Agreement, dated as of September 8, 1999 (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office on September 29, 1999 at Reel 1963, Frame 0662 and Reel 1968, Frame 0449, pursuant to which Assignees granted to Assignor, as Collateral Agent, a first priority continuing security interest, a second priority continuing security interest, and a third priority continuing security interest in and to the Trademarks and Trademark Licenses (as defined in the Collateral Agreement), including but not limited to those identified in Exhibit A to this Release, to secure the full and punctual payment of the Secured Obligations.

WHEREAS, Assignees have fully satisfied all their Secured Obligations under the Collateral Agreement and the Trademark Security Agreement (collectively, the "Security Agreements"); and Assignor desires to release its security interests in and liens upon the Assignees' Collateral pledged pursuant to said Security Agreements, including but not limited to, the Trademarks and Trademark Licenses.
