## RELEASE OF ASSIGNMENT OF TRADEMARKS AND PATENTS

G.S. SHATAN

This Relinquishment, effective as of August 4, 2000, is executed pursuant to a Loan Agreement dated as of August 1, 1994 between the Forum Corporation of North America, a Delaware Corporation (the "Company") and Fleet National Bank (f/k/a The First National Bank of Boston) (the "Bank").

1. Pursuant to the aforementioned Loan Agreement between the Company and the Bank, the Company executed an Assignment for Security in Trademarks on August 1, 1994 ("1994 Trademark Assignment") a true and correct copy of which is attached hereto as Exhibit 1.

2. The 1994 Trademark Assignment was recorded on August 8, 1994 in the records of the U.S. Patent and Trademark Office in Washington D.C. on Reel 1277, Frames 0476-0480.

3. Pursuant to the terms of the 1994 Trademark Assignment, the Company has requested that the Bank release and terminate any and all of the Bank's security interest in the Company's Marks (as defined in paragraph 1 of the 1994 Trademark Assignment), the good will of the business symbolized by the Marks and the registrations thereof, which the Bank acquired pursuant to the 1994 Trademark Assignment.

4. The Bank hereby releases and terminates any and all of its security interest in the Marks, the good will of the business symbolized by the Marks and the registrations thereof, for past, present, and future transactions or obligations of the Company that the Bank acquired pursuant to the 1994 Trademark Assignment.

5. The Company shall bear all costs and expenses incurred by the Bank in connection with this Release including, without limitation, fees and expenses incurred in connection with the preparation and recordation of this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Company does hereby assign and grant to the Lender a security interest in and to the Marks, together with the good will of the businesses symbolized by each of the Marks, and the registrations thereof, which assignment and security interest shall secure all the Obligations (as defined in the Agreements) in accordance with the terms and provisions thereof.
