

# TRADE MARK AND DOMAIN NAME ASSIGNMENT AGREEMENT

THIS AGREEMENT dated March 24<sup>th</sup>, 2000, is between INTERNATIONAL PROTECTIVE COATINGS CORP., a corporation organized under the laws of the state of Delaware, with a place of business at 1275 Highway 35, Middletown, New Jersey (hereinafter the "Company") and W. R. Grace & Co.-Conn., a corporation organized under the laws of the state of Connecticut, with a place of business at 1114 Avenue of the Americas, New York, New York, 10036 (hereinafter "Grace");

WHEREAS, Company is the sole exclusive owner of the trademarks, trade names and names in trade listed on the Schedule A hereto; and


WHEREAS, Grace is desirous of acquiring from Company an assignment of the entire worldwide right, title and interest in and to and under the said trademarks, tradenames and names in trade, and of the goodwill of Company's business associated with the same

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN,

Be it known that for good and valuable consideration paid by Grace, the receipt of which is hereby acknowledged, Company, has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to Grace, the trademarks, tradenames and names in trade listed in the Schedule A hereto together with the goodwill of Company's business connected with the use of and symbolized by such trademarks, tradenames and names in trade, the same to be held and enjoyed by Grace for its own use and enjoyment in the United States and all other countries of the world, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Company if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of said trademarks, tradenames and names in trade, with the right to sue for, and collect the same for its own use and behoof, and for the use and behoof of its successors, assigns or other legal representatives. Company agrees, that at the request of Grace it will make and execute any further assignment of said trademarks, tradenames and names in trade as may be necessary for filing or recording in the United States Patent and Trademark Office or in similar offices of any other country of the world. Company hereby authorizes and requests the Commissioner of Patents and Trademarks for the United States, and any other similar official of any other country of the world to issue any and all registrations of the United States or any other country of the world to the said Grace as assignee of the entire interest, and hereby covenants that it has the full right to convey the entire interest herein assigned.

In Testimony Whereof, Company has caused these presents to be signed by its officer, thereunto duly- authorized, and its corporate seal to be hereto affixed this 24<sup>th</sup> day of March, 2000.
