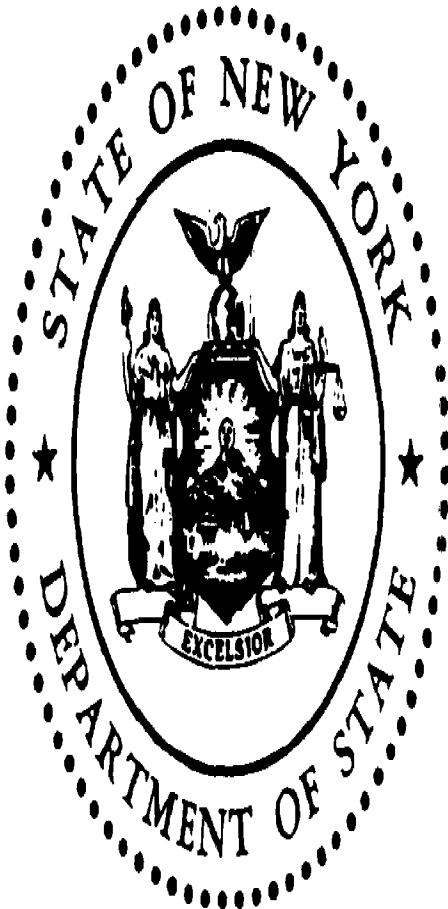


Under Section 805 of the Business Corporation Law

1. The name of the Corporation is SONICSTAR INTERNATIONAL LTD. which was formed under the name "Bond Acquisition Corporation".
