(U.S. CURAD TRADEMARK RIGHTS AND CURA TRADEMARKS)


Pursuant to the Collateral Assignment of U.S. Curad Trademark Rights and Cura Trademarks dated 29 December 1995 (the "Agreement"), by and between Tyco Healthcare Group LP, a Delaware limited partnership and successor in interest to The Kendall Company (the "Assignor") and Beiersdorf AG, a German stock corporation (the "Assignee"), the Assignee hereby acknowledges that the security interests created by the Agreement in the Curad Registered and Common Law Trademarks listed on Schedule A annexed hereto and in the trademarks with the prefix "Cura-" listed on Schedule B annexed hereto, were extinguished, ceased, released and terminated on December 1, 2000.
