

RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is made as of June 7, 1997 by The Chase Manhattan Bank, N.A., a national banking association with its principal place of business at One Chase Manhattan Plaza, New York, New York, 10081 (the "Secured Party").

WHEREAS, Wm. E. Wright Limited Partnership, a Delaware limited partnership with its principal place of business at South Street, West Warren, Massachusetts 01092 (the "Company") owns the trademarks and trademark applications listed on Exhibit A attached hereto ("Listed Trademarks"), which trademarks are registered and/or filed in the United States Patent and Trademark Office (the "Office") or corresponding offices of foreign countries; and

WHEREAS, the Company has granted to the Secured Party a security interest in (i) all of its trademarks, trademark registrations and trademark applications, including but not limited to the Listed Trademarks and (ii) any associated business goodwill therein ("Trademark Collateral"), all as described in that certain Pledge and Security Agreement, dated as of November 28, 1989, between the Secured Party and the Company, and that certain Collateral Assignment of Proprietary Rights and Security Agreement dated as of November 27, 1989 executed by the Company and the Secured Party ("Trademark Agreements"), previously filed for recordation in the Office on January 12, 1990 at Reel No. 0722, Frame No. 0001 and in the Canadian Office of Trade Marks, reference number 30650/00159; and

WHEREAS, the Secured Party has at the Company's request agreed to release its security interest in all of the Trademark Collateral, including but not limited to the Listed Trademarks, and any associated business goodwill therein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases the lien on and security interest in all of the Trademark Collateral, including but not limited to the Listed Trademarks, and any associated business goodwill therein, and to any other rights it might have arising out of the Trademark Agreements and hereby further quits all claims in and to any right, title or interest in the Trademark Collateral, including but not limited to the Listed Trademarks.

The Secured Party hereby undertakes and agrees to do such things and to execute such further lawful documents, assurances, applications and other instruments as may be required to give effective legal, registered and unencumbered title to the Company in and to the Trademark Collateral, including but not limited to the Listed Trademarks all without further considerations.
