**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Meridian Automotive Systems-Grand Rapids Operations, Inc., a Michigan corporation (the "Grantor") with principal offices at 550 Town Center Drive, Dearborn, Michigan 48126, hereby assigns and grants to Bank of America, N.A., as Administrative Agent, with offices at 1455 Market Street, 12th floor, San Francisco, California 94103-1399 (the "Grantee"), a security interest in (i) all of the Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Guarantee and Collateral Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

Upon the termination and satisfaction of the Guarantee and Collateral Agreement, the Grantee shall, upon such termination and satisfaction, execute, acknowledge and deliver to the Grantor an instrument in writing releasing the security interest in the Marks acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Guarantee and Collateral Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Guarantee and Collateral






