## TRADEMARK ASSIGNMENT

WHEREAS, Reliance Insurance Company, a Pennsylvania insurance company with a principal place of business at Three Parkway, Philadelphia, Pennsylvania 19102 (hereinafter "Assignor"), is the owner of the trademarks, trademark registrations, and trademark applications set forth in Schedule A attached hereto (the "Trademarks"); and

NOW, THEREFORE, effective as of the date hereof, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign unto Assignee, its successors and assigns all of its right, title, and interest in and to:

- (i) the Trademarks set forth on Schedule A hereto, and the goodwill symbolized thereby and associated therewith;
- (ii) all registrations (and all renewals thereof) and applications for registration of the Trademarks;
- (iii) the right to sue for any past, present or future infringement of the Trademarks and related claims, including the right to sue for injunctive relief and to collect damages; and
- (iv) all rights corresponding thereto throughout the world.
