ASSIGNMENT OF TRADEMARK RIGHTS

THIS ASSIGNMENT OF TRADEMARK RIGHTS (this "Assignment") made as of the 8th day of September, 2000, by and between Union Tools Irrigation, Inc., a corporation of the State of Delaware, ("ASSIGNOR"), and L.R. Nelson Corporation, a corporation of the State of Delaware, with offices at One Sprinkler Lane, Peoria, Illinois ("ASSIGNEE").

WITNESSETH:

WHEREAS, ASSIGNOR and ASSIGNEE have entered into that certain Asset Purchase Agreement, dated August 11, 2000 (the "Agreement"), wherein ASSIGNOR has agreed to sell to ASSIGNEE and ASSIGNEE has agreed to purchase from ASSIGNOR the Personal Property (as defined in the Agreement) used in, or related to, the Business (as defined in the Agreement); and

WHEREAS, ASSIGNOR has adopted and used, and is the exclusive owner of, certain trademarks used in, or related to the Business, including but not limited to any and all trade dress associated therewith, together with the goodwill of the Business symbolized thereby in connection with the products on which said trademarks are used (the "Products"); and

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver and contribute to ASSIGNEE all of its right, title and interest in and to said trademarks together with the goodwill associated therewith.

NOW, THEREFORE, ASSIGNOR and ASSIGNEE, in consideration of the mutual agreements herein contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, do hereby agree as follows:

1. ASSIGNOR hereby conveys, transfers, assigns, delivers and contributes to ASSIGNEE, effective as of the date hereof, all of the ASSIGNOR'S right, title and interest in and to any and all trademarks relating to the Business throughout the world, including but not limited to those trademarks set forth on Exhibit A attached hereto and by this reference incorporated herein, the United States Patent and Trademark Office and state registrations, renewals, applications and any other filings, certificates, affidavits or documents for or relating to said trademarks, whether issued, pending or otherwise, common law rights in and to said trademarks, together with (1) the goodwill of the Business relating to the Products in respect upon which said trademarks are used and for which they are registered; (2) all income, royalties and damages

hereafter due or payable to ASSIGNOR with respect to said trademarks and, including, without limitation, damages, and payments for past or future infringements and misappropriations of the trademarks; and (3) all rights to sue for past, present and future infringements or misappropriations of the trademarks (collectively, the "Marks").





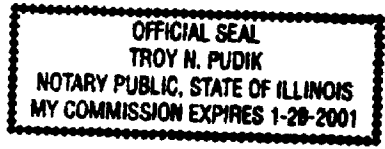
