CONDITIONAL REVERSION AND ASSIGNMENT

THIS CONDITIONAL REVERSION AND ASSIGNMENT (this "Reversion"), made and entered into this 28th day of May, 1999, by and between The Benjamin Ansehl Company, a Missouri Corporation ("Benjamin Ansehl") and Mediskin Technology, Inc., a Missouri Corporation ("MediSkin").

RECITALS

A. MediSkin obtained an assignment of even date herewith of any and all common law right, title and interest in and to the trademarks set forth on Schedule 1.1(c) of the Trademark Assignment and Inventory Purchase Agreement by and between MediSkin and Benjamin Ansehl (the "Purchase Agreement"), and as set forth on Exhibit A attached hereto, for certain medical related products including the goodwill symbolized by the trademarks (hereinafter the "Trademarks") from Benjamin Ansehl.

B. MediSkin has agreed to purchase all of the Inventory (as defined in the Agreement) within nine months from the date hereof.

C. Benjamin Ansehl and MediSkin have agreed that should the Inventory not be purchased within such nine month period or any extensions of such periods, which will not be unreasonably withheld, for any reason, that Benjamin Ansehl, in its sole discretion, may cause whatever right, title and interest in and to the Trademarks and the goodwill associated therewith that Benjamin Ansehl owned prior to the assignment of the Trademarks to MediSkin to revert to and be assigned back to Benjamin Ansehl.

AGREEMENT

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, that upon expiration of the nine month period commencing on the date hereof and any extensions of such periods, which will not be unreasonably withheld, granted by Benjamin Ansehl in writing and in its sole discretion and only in the event that MediSkin has not purchased all of the Inventory, MediSkin does hereby sell, assign and transfer unto said Benjamin Ansehl any and all of the right, title and interest, throughout the world, in and to said Trademarks that Benjamin Ansehl owned prior to the assignment of such rights to MediSkin, together with the good will of the business symbolized by the same. MediSkin represents and warrants that it has full power and authority to make such sale, assignment and transfer, and that it has not made, and will not make in the future, any other sale, assignment, transfer, license or otherwise pledged the Trademarks (in part or in their entireties) to any third party in contravention of this Reversion without the prior written consent of Benjamin Ansehl, which will not be unreasonably withheld.
