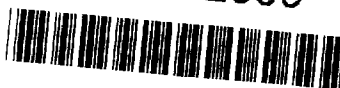

ASSIGNMENT

WHEREAS, SW INDUSTRIES, INC., a Delaware corporation (hereinafter "Assignor"), which has done business under, *inter alia*, the names "Stowe Woodward Company" and "Mount Hope Machinery Company", owns and has used the trademarks set forth in attached Schedule A: (hereinafter referred to as "the Marks"), which are the subject of applications for registration pending before the United States Patent and Trademark Office; and

This assignment is made Nunc Pro Tunc to make it express that the goodwill of the business symbolized by the Trademarks identified in Schedule A hereto was transferred from the Assignor to the Assignee, effective as of August 31, 1999.

Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title and interest in and to the Marks in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.


