**CERTIFICATE OF AMENDMENT
OF
CERTIFICATE OF INCORPORATION**

B & L International Holdings Corp., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify:

FIRST: That the Board of Directors of B & L International Holdings Corp., by unanimous written consent dated August 21, 2000, adopted a resolution approving a proposed amendment to the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the sole shareholder of said corporation for consideration thereof. The resolution approving the proposed amendment is as follows:


RESOLVED, that the Certificate of Incorporation of this corporation be amended by changing the Article First thereof so that, as amended, said Article shall be and read as follows:

"The name of the corporation is Polymer Technology (U.S.A.) Corporation."

SECOND: That, pursuant to resolution of its Board of Directors, a special meeting of the sole shareholder of said corporation was duly called and, upon written waiver of notice signed by the sole shareholder in accordance with Section 222 of the General Corporation Law of the State of Delaware, the necessary number of shares as required by statute were voted in favor of the amendment.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware. This Certificate of Amendment of the Certificate of Incorporation shall be effective on the date of filing with the State of Delaware Office of the Secretary of State.
