

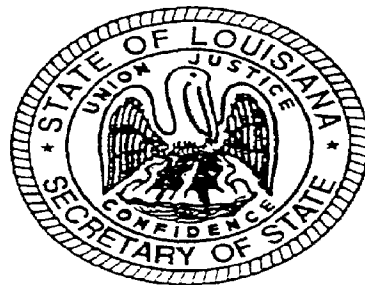


FIRST: The Restated Articles of Incorporation of this corporation are hereby amended so that Article I thereof shall read as follows:

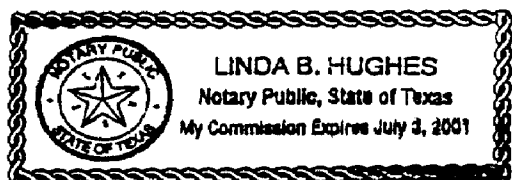



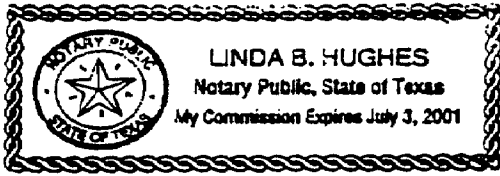
