ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

A. Nestlé USA, Inc., a Delaware corporation ("NUSA"), and nutrisystem.com inc., a Delaware corporation ("Buyer"), have entered into that certain Asset Purchase Agreement, dated as of August 25, 2000 (the "Asset Purchase Agreement"), pursuant to which NUSA has agreed to sell, and Buyer has agreed to buy, certain assets; and

B. Société des Produits Nestlé S.A., a Société Anonyme organized under the laws of Switzerland ("SPN"), Nestec Ltd., a corporation organized under the laws of Switzerland (collectively, "Seller"), NUSA and Buyer have entered into that certain Intellectual Property Purchase Agreement, dated as of August 25, 2000 (the "Intellectual Property Purchase Agreement"), pursuant to which Seller has agreed to sell to NUSA, and NUSA has agreed to buy from Seller, and simultaneously with such sale and purchase, NUSA has agreed to sell to Buyer, and Buyer has agreed to buy from NUSA, certain intellectual property, including the trademarks set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SPN hereby assigns and transfers to NUSA and, simultaneously with such assignment and transfer, NUSA hereby assigns and transfers to Buyer all of its right, title and interest in and to (i) the Transferred Intellectual Property, including the trademarks set forth on Schedule A hereto, as defined in the Intellectual Property Purchase Agreement and the goodwill associated therewith and (ii) the trade dress used by NUSA in connection with the sale of products that are labeled with the "SWEET SUCCESS" trademark; *provided, however*, that such assignments and transfers to NUSA and Buyer, respectively, do not include, and SPN expressly retains, SPN's right, title and interest in and to any and all Excluded Intellectual Property (as defined in the Intellectual Property Purchase Agreement) owned or possessed by SPN.


