




NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby release its security interest in, to or under the Trademark and Patent, granted to the Secured Party pursuant to the Memorandum, together with the goodwill of the business, title and interest of the Secured Party in, to and under the Trademark and Patent shall hereby cease and become void.
