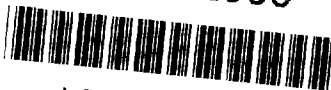

WHEREAS, Assignor wishes to assign all its rights in the Mark, the Goodwill and the Registration to Assignee; and


WHEREAS, Assignee wishes to obtain all of Assignor's rights in the Mark, the Goodwill and the Registration:
