

1. The name of the corporation is

J. T. BAKER INC.

2. The following amendment to the Certificate of Incorporation was approved by the directors and thereafter duly adopted by the sole shareholder of the corporation on the 27th day of June, 1995:

Resolved, that Articles FIRST of the Certificate of Incorporation be amended to read as follows:

FIRST: The name of the corporation is **MALLINCKRODT BAKER, INC.**

3. The number of shares entitled to vote upon the amendment was One Hundred Nine Thousand Seven Hundred and Seven (109,707).

4. That in lieu of a meeting and vote of the sole shareholder and in accordance with the provisions of Section 14A:5-6, the amendment was adopted by the sole shareholder without a meeting pursuant to the written consent of the shareholder and the number of shares represented by such consent is One Hundred Nine Thousand Seven Hundred and Seven (109,707) shares.

5. The effective date of this Amendment to the Certificate of Incorporation shall be June 30, 1995.
