TRADEMARK RELEASE

This Release granted on this 23rd day of August, 2000, by The Northern Trust Company, as Agent ("Agent"), to SCP Communications, Inc., PRR, Inc. and CM Publishing Limited Partnership (d/b/a Cliggott Publishing Co. and Cliggott Communications) (collectively, the "Grantors"), as follows:
