WORLDWIDE TRADEMARK ASSIGNMENT

WHEREAS, ALLIEDSIGNAL INC., a Delaware Corporation with an address at 101 Columbia Rd., P.O. Assignor shall, without further consideration, execute any additional documents and take such further action, upon Assignee's request and at Assignee's expense, to vest in


Assignee good, valid and marketable title in and to the Trademark Rights, including, without limitation, the execution of additional documents necessary to effect and record the assignment of Trademark Rights to Assignee, or its successors and assigns, in the U.S. and foreign Patent and Trademark Offices. Assignor acknowledges that one or more of the applications/registrations of the Trademark Rights may currently be in the name of a predecessor in interest of Assignor. Assignor shall, upon Assignee's request and at Assignee's expense, take such action to complete the chain of title of such applications/registrations to effect recordal of the assignment in the name of Assignee.

Assignee, for itself, its successors and assignees, agree not to use nor license others to use the PRESTOLITE mark for spark plugs, glow plugs and igniters for internal combustion engines anywhere in the world.
