

THIS RELEASE is made as of the 7 day of August, 2000, by MERCANTILE-SAFE DEPOSIT AND TRUST COMPANY ("LENDER") in favor of OPTICAL SECURITY GROUP, INC. and OPTICAL SECURITY INDUSTRIES, INC. (collectively, "OPTICAL").

RECITALS





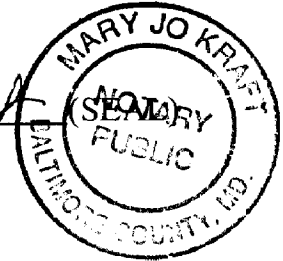
