THIS ASSIGNMENT is made 22 January 1998

BETWEEN

- (1) **BOC LIMITED** an English Company with registered number 337663 of Chertsey Road, Windlesham, Surrey, GU20 6HJ, England (hereinafter referred to as the "Assignor") of the one part; and
- (2) **SAVANT INSTRUMENTS, INC.** a company incorporated in the state of New York with federal identification number 13-3023158 and whose registered office is at 100 Colin Drive, Holbrook, New York 11741, United States of America (hereinafter called the "Assignee") of the other part

WHEREAS :

- 1) The Assignor is the proprietor and beneficial owner of the registered trademark short particulars of which are shown in the Schedule hereto and which is hereinafter referred to as "the said Trademark" together with the goodwill of the business in the goods in relation to which the said Trademark is registered.
- 2) By an agreement made between Savant Instruments Inc, Edwards High Vacuum International Limited and BOC Limited dated 22 January 1998 the Assignor has agreed to assign said Trademark and the goodwill accruing thereto and has agreed to execute a formal assignment of the trademark rights in favour of the Assignee upon the terms hereinafter contained.

NOW THIS DEED WITNESSETH as follows:

- 1) In pursuance of said agreement and in consideration of the sum of £8,500 now paid by the Assignee to the Assignor (the receipt of which is hereby acknowledged) the Assignor as beneficial owner hereby assigns to the Assignee with full title guarantee all rights, title and interest in the said Trademark specified in the Schedule hereto together with all its rights, powers, privileges and immunities arising or accrued therefrom including the right to take such proceedings as maybe necessary for the recovery of damages or

otherwise in respect of infringements committed before as well as after the date hereof and including the goodwill in the said Trademark for the goods in relation to which the said Trademark is registered.


- 2) The Assignor shall at the expense of the Assignee do and execute or procure that there shall be done and executed all such documents deeds matters acts and things as the Assignee may at any time reasonably require properly to vest the said Trade Mark in the Assignee or otherwise to give effect to this Assignment.

THIS ASSIGNMENT shall be interpreted according to the laws of England and the parties hereto shall subject themselves to the English courts.
