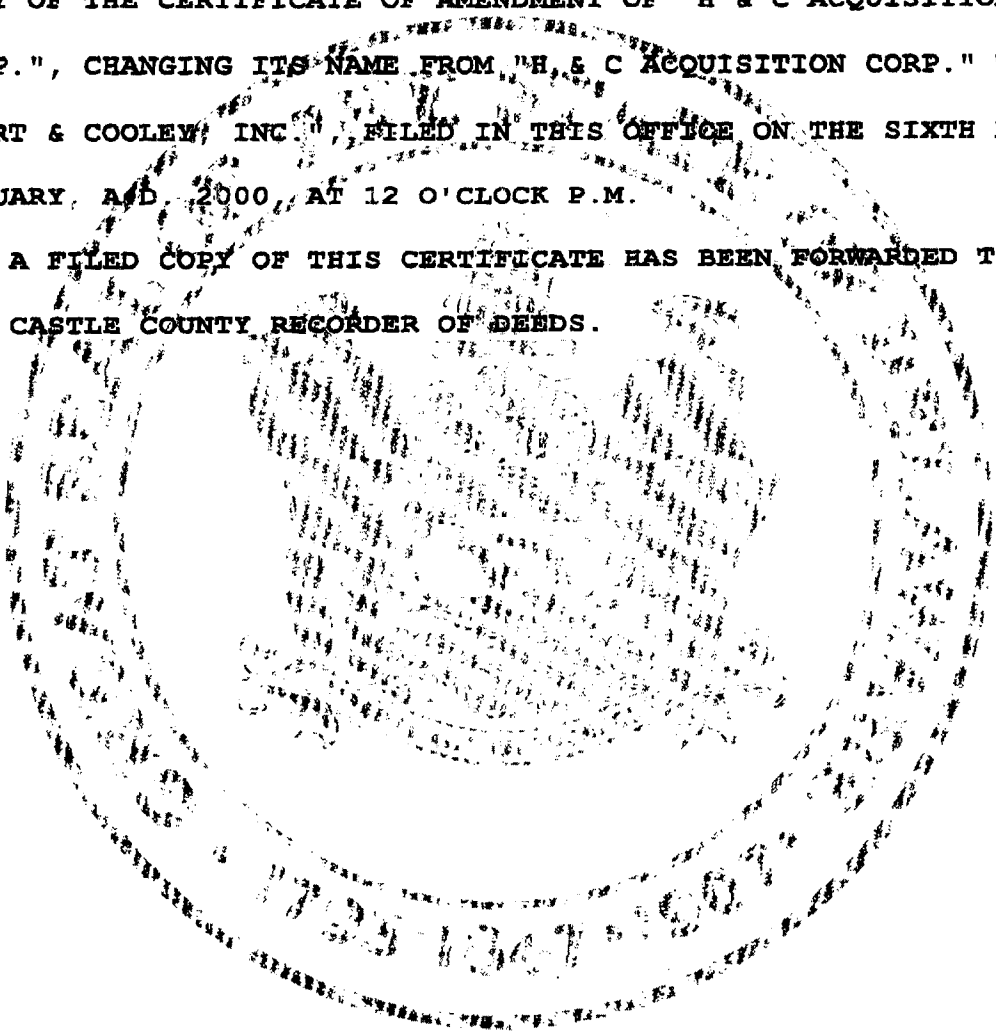

The name of the corporation is Hart & Cooley, Inc. (the "Corporation").


