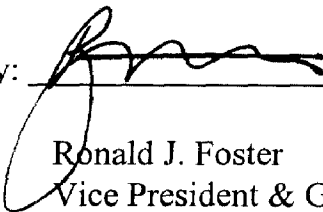

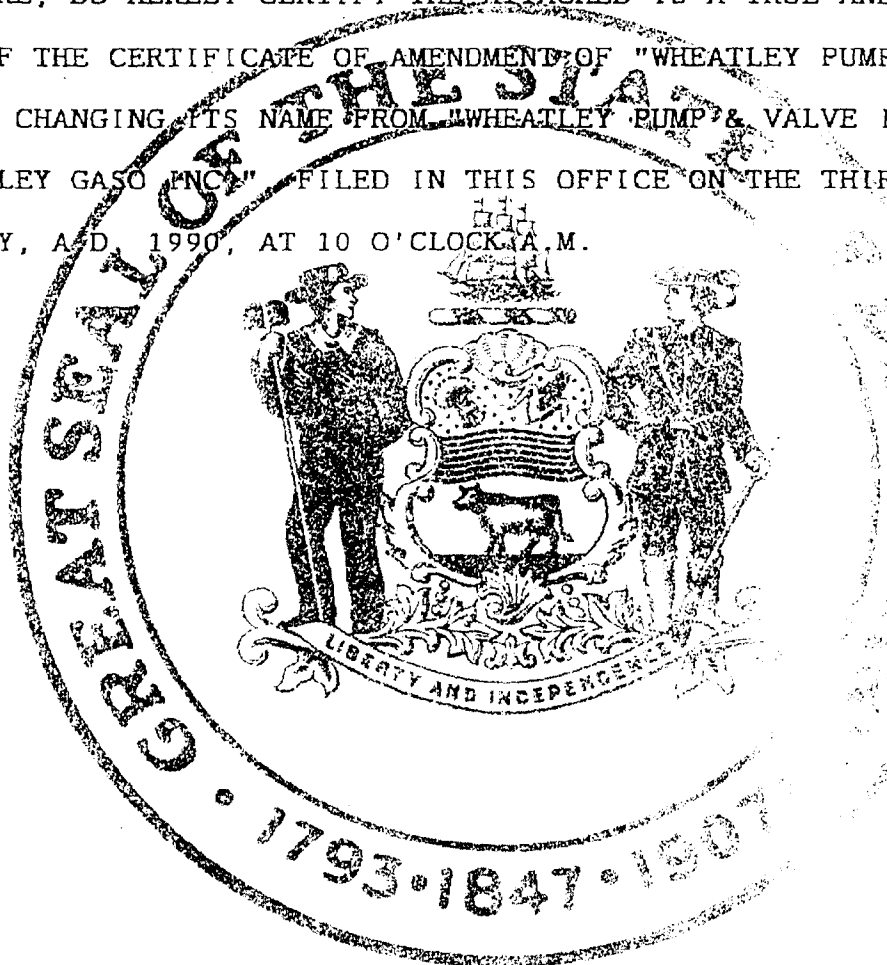

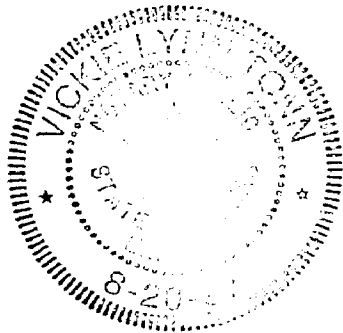

RESTATED CERTIFICATE OF INCORPORATION

Wheatley Pump & Valve Inc., a Delaware corporation (the "Corporation"), acting pursuant to Section 242(b) of the Delaware General Corporation Law ("GCL") does hereby certify the following:

FIRST: That the Board of Directors of the Corporation through the sole director's Consent, has adopted resolutions setting forth a proposed amendment to the Restated Certificate of Incorporation of the Corporation, declaring said amendment advisable and calling for the submission of such amendment to the stockholders of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that Article FIRST of the Restated Certificate of Incorporation of the Corporation be amended to read in full as follows:

"FIRST; the name of the corporation is Wheatley Gaso Inc."

SECOND: That, acting in accordance with Section 228(a) of the GCL, the holder of a majority of the outstanding common stock of the Corporation entitled to vote thereon duly authorized the Amendment by its written Consent, dated as of December 15, 1989, which Consent was filed in the minute book of the Corporation.

THIRD: That, acting in accordance with Section 228(d) of the GCL, prompt notice of the taking of the corporate action without a meeting by less than unanimous written consent shall be given to those stockholders who did not consent in writing.

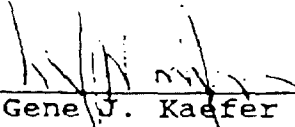

FIFTH: That, the capital of the corporation will not be reduced under or by reason of the foregoing Amendment.

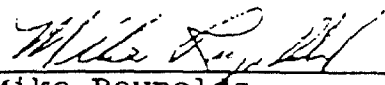
