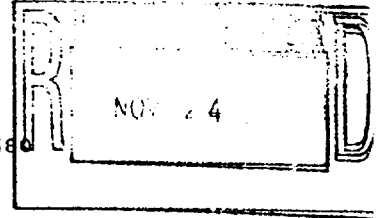

ASSIGNMENT

The ASSIGNOR hereby clarifies that the phrase "quit claim" as used herein shall be construed in accordance with the definitions of "Quitclaim, v," "Quitclaim, n," and "Quitclaim deed," that appear in Black's Law Dictionary, Fifth Edition, 1126 (West Publishing Co. 1979),

including "conveyance operating by way of release ... intended to pass any title, interest, or claim which the grantor may have ... but not professing that such title is valid, nor containing any warranty or covenants for title," and the ASSIGNEE understands that it is acquiring by this Assignment only such right, title, interest, and registration that the ASSIGNOR possesses.

The ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks to issue any and all certificates of registration of the Mark to the ASSIGNEE as the owner of the entire interest of said Mark, for the sole use and behoof of the said ASSIGNEE, its successors, assigns and legal representatives.

This Assignment and Agreement shall be binding upon any and all successors of the ASSIGNOR.

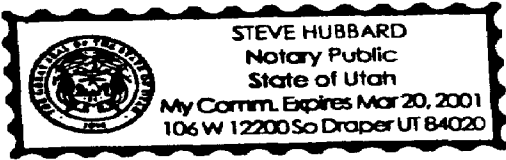
