This **RELEASE** is given as of this 14<sup>th</sup> day of November 2000 by Citibank, N.A., a national banking association ("Assignor"), located at 399 Park Avenue, New York, New York 10043, in favor of Dallas Cowboys Football Club, Ltd., a Texas limited partnership ("Assignee"), located at 1 Cowboys Parkway, Irving, Texas 75063.
