**TERMINATION AND RELEASE  
OF SECURITY INTERESTS  
IN CERTAIN TRADEMARKS**

**TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS** (the "Release"), dated as of September 15, 2000, by **FLEET NATIONAL BANK** (successor by merger to Fleet Bank, N.A.), a national banking association with an office at 1185 Avenue of the Americas, New York, New York 10036, as agent (the "Agent") for itself and the other lending institutions (hereinafter, collectively, the "Banks") which are parties to that certain Revolving and Term Credit Agreement, dated as of August 15, 1997 (as amended, restated or modified and in effect from time to time, the "Credit Agreement"), among Carey International, Inc., the Agent and the Banks.

**WHEREAS**, pursuant to the terms of (i) the Credit Agreement, (ii) the Security Agreement and Assignment, dated as of August 15, 1997, between Carey Licensing, Inc. (the "Assignor") and the Agent (the "Security Agreement"), and (iii) the Confirmation of Trademark and Service Mark Security Interest, dated as of August 15, 1997, of the Assignor and recorded with the PTO on or about August 25, 1997 (Trademark Reel 1623 and Frame 0310) (as amended and supplemented from time to time, the "Confirmation of Trademark"), each for the purpose of securing certain obligations of the Assignor to the Agent, on behalf of itself and the Banks;

**WHEREAS**, pursuant to the Credit Agreement, the Security Agreement and the Confirmation of Trademark, the Assignor granted to the Agent, for the benefit of the Banks, a security interest in and lien on, and collaterally assigned to the Agent all of its trademarks, trademark registrations and associated goodwill, including, without limitation, the trademarks identified on Exhibit A attached hereto) (such trademarks referred to herein as the "Named Trademarks"); and


**WHEREAS**, the Agent has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent and the Assignor hereby agree as follows:


1. **Release and Assignment.** The Agent hereby terminates and releases its security interest in and first priority lien on all of the Assignor's Named Trademarks, and the Agent hereby assigns and transfers to the Assignor, without recourse, all of the Agent's right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill, effective as of the date set forth above.
2. **Acknowledgment and Acceptance.** The Assignor hereby acknowledges and accepts the foregoing release and assignment by the Agent.
3. **Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
