

**MEMORANDUM OF LICENSE AGREEMENT**

THIS MEMORANDUM OF LICENSE AGREEMENT (the "Memorandum") is made as of July 7, 2000, among IMC-Agrico Company, a Delaware general partnership having a business address at 2345 Waukegan Road, Bannockburn, Illinois 60015 and Phosphate Resource Partners Limited Partnership, a Delaware limited partnership having a business address at 2345 Waukegan Road, Bannockburn, Illinois 60015 (collectively the "Licensors"), and The Agrotain Company, LLC, a Missouri limited liability company, having a business address at One Angelica Street, St. Louis, Missouri 63147 (the "Licensee").

**WITNESSETH**

WHEREAS, on July 7, 2000, Licensors and Licensee entered into a License Agreement (the "Agreement") with respect to the licensing of certain patents and trademarks owned or controlled by Licensors, several of which were issued by or registered in the U.S. Patent and Trademark Office (collectively, the "U.S. Intellectual Property"), for use in protecting certain urease inhibitors and related products; and

WHEREAS, Licensors and Licensee desire to provide notice of the Agreement and certain terms and provisions contained therein by recordation of this Memorandum against the U.S. Intellectual Property listed on Schedule A (being the United States issued patents portion of the "Licensed Patents") and Schedule B (being the United States issued trademarks portion of the "Licensed Trademarks") attached hereto and by this reference, incorporated herein.

NOW, THEREFORE, Licensors and Licensee hereby give notice of the following matters contained in or with respect to the Agreement:

1. **Definitions.** The capitalized terms used in this Memorandum, unless the context requires otherwise, are defined herein and have the same meanings as set forth in the Agreement. Those additional capitalized terms pertinent to this Memorandum are as follows:

*Affiliate* shall mean any person or entity which, directly or indirectly through one or more intermediaries, controls, is controlled by or is under the common control of any party hereto.

*Agrotain* shall mean a Urease Inhibitor product developed by Licensors and comprised of a Urease Inhibitor in a proprietary solvent formulation of Licensors.

*Business* shall mean the business of developing, manufacturing, selling and distributing Urease Inhibitors, Agrotain and the Super Products and all other products, the manufacture or use of which is covered under the scope of any one or more claims of the Licensed Patents and the Urease Inhibitor Patents for **exclusive** applications in: (i) enhancing, regulating or effecting, directly or in combination with nitrogen fertilizers or other products, the growth of any and every kind of plants (including, without limitation, crops), and (ii) all odor control uses, except the Odor Control Business. *Business* shall also mean the business of developing, manufacturing, selling and distributing Urease Inhibitors, Agrotain, the Super Products and all other products, the manufacture or use of which is covered under the scope of any one or more claims of the Licensed Patents and the Urease Inhibitor Patents for **non-exclusive** applications in testing, research and development, but not the commercialization or sale, of any product or process. *Business* shall not include the Odor Control Business or the Existing Products Business.

*Existing Products Business* shall mean the business of developing, manufacturing, selling and distributing those products which Licensors currently develop, manufacture, sell and distribute, and which comprise phosphate and potash animal feed products, diammonium phosphate (a.k.a. "DAP"), monoammonium phosphate (a.k.a. "MAP"), potash, including sulfate of potash (a.k.a. "SOP") and sulfate of potash magnesia (a.k.a. "Sul-Po-Mag"), triple super phosphate, and derivatives and combinations thereof.

*Odor Control Business* shall mean the business of developing, manufacturing, using, selling or distributing products for applications in Production Animal ammonia and waste odor control.

*Production Animals* shall mean cattle, hogs or poultry, and any other mammals or fowl raised for food consumption or hunted as game.

*Super Products* shall mean any products whose manufacture, use or sale is covered under the scope of any one or more claims of Licensors' United States Patents No. 4,994,100; 5,352,265 and 5,364,438, and their respective foreign patent equivalents.

*Urease Inhibitor* shall mean a compound within the scope of a claim of the Urease Inhibitor Patents or mixtures of two or more of said compounds.

*Urease Inhibitor Patents* shall mean, *inter alia*, the United States patents: 4,540,428; 4,462,819; 4,539,037; 4,517,002; 4,530,714; 4,517,003; 4,517,005; 4,517,004; 4,518,413; 4,528,020; 4,517,007; 4,537,614; 4,629,491; 4,696,693; 4,824,783; and 4,624,695, and any reissues, continuations and/or divisions thereof; all of which have been sub-licensed by Licensors to Licensee pursuant to the limitations, terms and conditions of that certain Sublicense Agreement dated as of July 7, 2000 (the "Sublicense Agreement").

2. License Grant. Subject to the limitations, terms and conditions set forth in the Agreement, Licensors granted to Licensee an exclusive license to use and apply the Licensed Patents and the Licensed Trademarks


throughout the world solely for and in connection with the operation of the Business.

- 3. Term. The Agreement shall terminate upon the expiration of the last-to-expire Licensed Patent or December 31, 2015, whichever occurs first.
- 4. Entire Agreement. Executed counterparts of the Agreement, which set forth the rights and obligations of Licensors and Licensee with respect to the subject matter hereof, is contained in the files of the parties hereto.




