Statement re Correction of Name of Registrant

Erroneous Registrant Name: R. A. Phillips, Inc.

Correct Registrant Name: R. A. Phillips Industries, Inc.

I, Hayden A. Carney, am a member in good standing of the State Bar of California and have been so since 1964. I am a member of the intellectual property law firm of Christie, Parker & Hale (“CPH”) located in Pasadena, California.

In 1988 or so, CPH and I began to represent a privately-owned business of which Mr. Robert A. Phillips then was and still is President. That business existed as a California corporation and conducted its business under a series of “dbas” on fictitious names, in each of which “Phillips” was the distinctive word. The California corporation also had different names at different times. In the records of the State of California (Office of the Secretary of State), that corporation has consistently been identified by Corporate Number 564095.

California corporation no. 564 095 has had different names at different times. Before February 19, 1992, that corporation was named HWP Group, Inc. On February 19, 1992, corporation no. 564095 changed its name to R.A. Phillips Industries, Inc., which is its name today. Those facts are confirmed by the attached copy of a report developed at my direction by access to an online corporate records database maintained by the California Secretary of State. The entry important to the generation of that report is the corporate name “R. A. Phillips Industries, Inc.”.


Also attached is a copy of a similar report developed at my direction from the same database using the entry corporate name “R. A. Phillips.” That report shows there is no such California corporation of that name either today or at any time encompassed by those official records.

Also attached hereto are copies of U.S. Trademark Registrations 1,889,719 and 2,016,822. Both of them, as issued, identify the registrant as R. A. Phillips, Inc. I prepared and prosecuted the applications resulting in those registrations. They were filed in 1994. At the time of their preparation, I was aware that the corporation had changed its name. I was informed then that the new name was R. A. Phillips, Inc., doing business as Phillips Industries. As shown above, that information was not correct. The correct name of the corporation then was and now is R. A. Phillips Industries, Inc. It does business as Phillips Industries.

Recently, R. A. Phillips Industries, Inc., moved its corporate offices to 12012 Burke Street, Santa Fe Springs, California 90670.

Therefore, it is proper that the information about the ownership of these registrations be adjusted and corrected to identify the registrant as R. A. Phillips Industries, Inc., dba Phillips Industries.

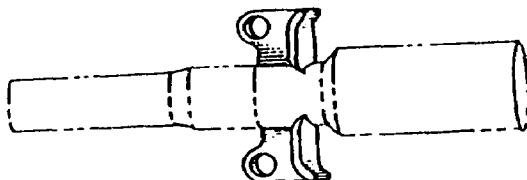
