TRADEMARK ASSIGNMENT



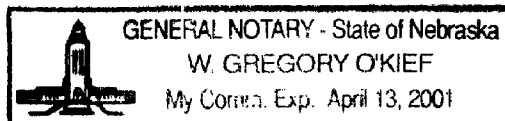
