#### RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (the "Release") is executed as of the day of September, 2000, by CITIBANK, N.A., AS ADMINISTRATIVE AGENT (the "Citibank") under the Credit Agreement among Citibank, the Lenders therein and Ambar, Inc., originally dated as of August 14, 1997, as amended (together with all amendments the "Credit Agreement").


