Amended and Restated Trademark Security Agreement

WHEREAS, Exide Corporation, a Delaware corporation located at 645 Penn Street, Reading, Pennsylvania 19601 (herein referred to as "Grantor"), owns all right, title and interest in, to and under the trademark registrations listed on the annexed Schedule A, which trademarks are registered with the United States Patent and Trademark Office and the appropriate authorities in all other applicable nations, including without limitation the nations listed on Schedule A, and any common-law rights related thereto (the "Trademarks");

WHEREAS, Grantor is obligated to Credit Suisse First Boston, a New York banking corporation, located at Eleven Madison Avenue, New York, New York 10010 as Administrative Agent (herein referred to as "Grantee") for the Lenders referred to in the Credit and Guarantee Agreement dated as of December 19, 1997, as amended by the Amended and Restated Credit and Guarantee Agreement, dated as of September 28, 2000 (as amended, supplemented or otherwise modified from time to time), and has entered into a Collateral Agreement dated as of December 19, 1997, as amended by the Amended and Restated Collateral Agreement, dated as of September 28, 2000 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement") in favor of Grantee; and

WHEREAS, pursuant to the Collateral Agreement, Grantor has conveyed to Grantee a security interest in, and mortgage on, all right, title and interest of Grantor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement or other impairment thereof (the "Collateral"), to secure the payment, performance and observance of certain Obligations (as defined in the Collateral Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged by both parties, Grantor does hereby further convey to Grantee a security interest in, and mortgage on, the Collateral to secure the prompt payment, performance and observance of the Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Grantee with respect to the security interest in and mortgage on the Collateral made and granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

This Trademark Security Agreement may be executed by one or more of the parties to this Trademark Security Agreement on any number of separate counterparts (including by facsimile transmission), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.

IN WITNESS WHEREOF, Grantor has caused this Trademark Security Agreement to be duly executed by its offices thereunto duly authorized as of the 28th day of September, 2000.
