ASSIGNOR, on behalf of itself, its subsidiaries and affiliates, also agrees to do all lawful things and to execute all additional lawful documents that ASSIGNEE believes are necessary or desirable to vest in the ASSIGNEE all right, title and interest in and to the Trademark SAFECHEX (including execution of any past or future applications and registrations therefor), and the goodwill of the business in connection with which it is or has been used.
