CERTIFICATE OF OWNERSHIP AND MERGER

(Pursuant to Section 253 of the General  
Corporation Law of the State of Delaware)

ClinTrials Inc., a Delaware corporation (the "Company"), does hereby certify:

FIRST: That the Company is incorporated pursuant to the Delaware General Corporation Law.

SECOND: That the Company owns all of the outstanding shares of the stock of ClinTrials Newco Inc. ("CNI"), a corporation which is incorporated pursuant to the Delaware General Corporation Law.

THIRD: That the Company, by the following resolutions of its Directors duly adopted on the 16th day of December, 1993, determined that it is in the best interests of the Company to merge CNI into the Company, effective as of 12:01 a.m. on February 11, 1994 (the "Effective Date of the Merger") and thereby to change the name of the Company to "ClinTrials Research Inc." on the Effective Date of the Merger, on the terms described in such resolutions, which provide as follows:

"NOW, THEREFORE, BE IT RESOLVED, that the Company merge CNI into the Company and assume all of CNI's liabilities and obligations effective as of the Effective Date of the Merger;

FURTHER RESOLVED, that the corporate name of the Company, as the surviving corporation, be changed to "ClinTrials Research Inc." effective as of the Effective Date of the Merger;

FURTHER RESOLVED, that the merger of CNI into the Company, other than to change the name of the Company as provided herein, shall not have any effect on the Certificate of Incorporation, bylaws, or authorized, issued or outstanding stock of the Company, and pursuant to such merger all the issued stock of CNI shall be cancelled;

FURTHER RESOLVED, that the Chairman of the Board, President or any Vice President of the Company is hereby authorized and directed to make and execute, and the Secretary or any Assistant Secretary of the Company is hereby authorized and directed to attest, under the corporate seal of the Company, a Certificate of Ownership and Merger, setting forth the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and to record a certified copy thereof in the office of the Recorder of Deeds for New Castle County, Delaware; and

FURTHER RESOLVED, that the officers of the Company are hereby authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be necessary or proper to effect such merger and change of name, and to take any and all action required as the result of the change of name."
