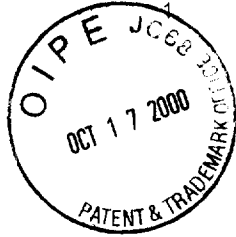

CERTIFICATE OF AMENDMENT
OF THE CERTIFICATE OF INCORPORATION

OF

NPES The Association for Suppliers of Printing

UNDER SECTION 803 OF THE NOT-FOR-PROFIT CORPORATION LAW

* * * * *

1. The name of the corporation is NPES The Association for Suppliers of Printing and Publishing Technologies, Inc. The name under which the corporation was formed is Printing Equipment Association, Inc.

2. The certificate of incorporation of said corporation was filed by the Department of State on the 22nd day of August, 1933. The said corporation was formed under the Membership Corporations Law of the State of New York.

3. The corporation is a corporation as defined in subparagraph (a)(5) of section 102 of the not-for-profit corporation law.

4. (a) The certificate of incorporation is amended to change the name of the corporation to NPES The Association for Suppliers of Printing, Publishing and Converting Technologies, Inc.

(b) To effect the foregoing, Paragraph (1) of the certificate of incorporation relating to the corporate name is amended to read as follows:

"FIRST: The name of the corporation is NPES The Association for Suppliers of Printing, Publishing and Converting Technologies, Inc."

5. The manner in which this amendment to the certificate of incorporation of NPES The Association for Suppliers of Printing and Publishing Technologies, Inc. was authorized was by an affirmative vote of all votes cast at a meeting of the members duly called and held on the 15th day of November, 1998.



7. The type of corporation which this corporation is under section 201 of the not-for-profit corporation law is type A.



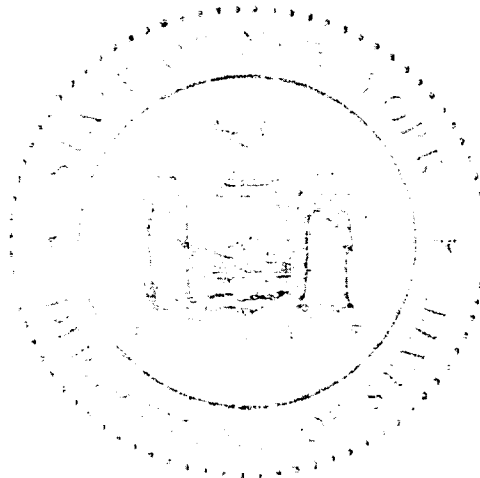
