TRADEMARK ASSIGNMENT

WHEREAS, Waldon, Inc., an Oklahoma corporation ("Assignor") has certain rights with respect to the "Lay-Mor", Letter "W" stylized "W", "Waldon" name with stylized "W", "Waldon" name with stylized "W", Letter "W" stylized "W", and "Waldon" name with graphics marks in connection with certain machinery and equipment, all as further described on Exhibit A (the "Marks"); and

WHEREAS, Mobile Products, Inc., a Kansas corporation ("Assignee") desires to acquire Assignor's entire rights, title and interest in and to said Marks and the goodwill associated therewith (the "Trademark Rights").

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

Section 1. Assignment. Assignor hereby sells, assigns, transfers and sets over unto Assignee, its successors and assigns, Assignor's entire rights, title and interest in and to the Trademark Rights, together with that portion of the good will of the business of Assignor connected with the use of and symbolized by the trademarks included in the Trademark Rights and the know how associated with and necessary to control the nature and quality of goods associated with the Trademark Rights, all common law rights and all causes of action, past, present and future for infringement of the Trademark Rights.

Section 2. Further Assurances. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Trademark Rights in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns, such facts relating to the Trademark Rights or the history thereof as may be known to it.

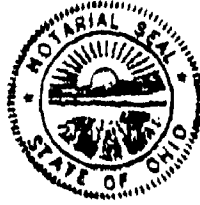
