Trademarks

WHEREAS, PEERLESS TUBE COMPANY, a New Jersey corporation (herein referred to as "**Assignor**"), has adopted, used and is using the trademarks listed in Schedule 1-A attached hereto and made a part hereof, which trademarks are registered or pending registration in the United States Patent and Trademark Office, and has adopted, used and is using the common law trademarks and trade names listed in Schedule 1-B attached hereto and made a part hereof (collectively, the "**Trademarks**"). This Assignment shall amend, replace and supersede in its entirety the Assignment for Security Trademarks between Borrower and Lender dated July 29, 1999 (the "Old Assignment"). This Assignment shall in no way be construed to, nor shall it affect, modify, diminish or break the continuity of our security interest in trademarks, trade names, terms, designs, registrations, and applications as more fully described in said Old Assignment which security interest is hereby ratified and confirmed by this Assignment as provided herein.

WHEREAS, Assignor is obligated to THE CIT GROUP/BUSINESS CREDIT, INC. as successor by merger to The CIT Group/Credit Finance, Inc., a New York corporation (herein referred to as "**Assignee**"), and has entered into a Trademark and Patent Security Agreement dated the date hereof (the "**Agreement**") in favor of Assignee; and

WHEREAS, pursuant to the Agreement, Assignor has assigned to Assignee and granted to Assignee a security interest in, and mortgage on, all right, title and interest to Assignor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof, all as more fully described in the Agreement (the "**Collateral**"), to secure the payment, performance and observance of the Obligations, as defined in the Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby further assign unto Assignee and grant to Assignee a security interest in, and mortgage on, the Collateral to secure the prompt payment, performance and observance of the Obligations.

Assignor does hereby further acknowledge and affirm that the rights and remedies of Assignee with respect to the assignment of, security interest in and mortgage on the Collateral made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

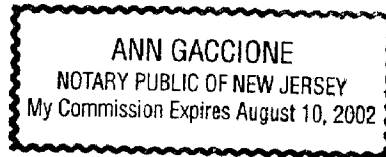
