
"The name of the corporation (herein called the "Corporation") is Fragrance Solutions, Inc. "

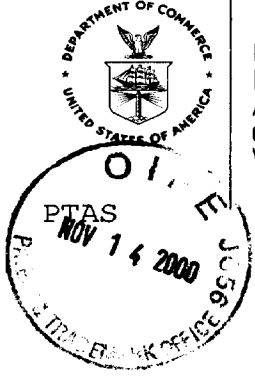
