TRADEMARK ASSIGNMENT

This agreement ("Agreement") entered into by and between Farnam Companies, Inc., an Arizona corporation with an office at 301 West Osborn Road, Phoenix, AZ 85013-3997, ("FARNAM") and Merial Limited, a company limited by shares registered in England and Wales (registered number 3332751) with a registered office at 27 Knightsbridge, London SW1X7QT, England, and domesticated in Delaware, USA, as Merial LLC (hereinafter 'MERIAL').

WHEREAS, in accordance with a Distributorship Agreement, dated December 10, 1995, between Farnam and Merck & Co., Inc. ("Distributorship Agreement"), Farnam has adopted, used, and is using the following trademark ("Trademark"), which is registered in the U.S. Patent and Trademark Office as follows:

WHEREAS, MERIAL is the successor-in-interest to all of the rights and obligations of Merck & Co., Inc. under the Distributorship Agreement; and

WHEREAS, MERIAL wishes to acquire the Trademark and registration;

NOW, THEREFORE, for good and valuable consideration, including the consideration recited in the Distributorship Agreement, the sufficiency and receipt of which is hereby acknowledged, it is agreed that:

FARNAM does hereby assign and transfer to MERIAL, all right, title and interest in and to the Trademark and the registration of the Trademark, together with the good will of the business symbolized by the Trademark, and together with all rights of action, claims for damages, profits and costs, and all other demands for any sum or sums of money whatsoever which it has or may have either at law or in equity, against any and all persons, firms, corporations or associations by reason of any infringement upon the Trademark.
