DEED OF ASSIGNMENT**DATED**

July 19, 2000

PARTIES:

- (1) **BOO.COM GROUP LIMITED** (in liquidation), a company registered in England and Wales with registration number 03638277 and whose registered office is at 5-7 Carnaby Street, London W1V 1PG ("**Group Limited**") acting by its joint Liquidators Philip Wallace and Michael McLoughlin of KPMG, 20 Farringdon Street, London EC4A 4PP ("**the English Liquidators**");
- (2) **BOO.COM IRELAND LIMITED** (in liquidation), formally known as "Bronco Ville Limited", a company registered in the Republic of Ireland with registration number 299587 and whose registered office is at Block 1, Harcourt Centre, Harcourt Street, Dublin 2, The Republic of Ireland ("**Ireland Limited**" and together with Group Limited "**the Assignors**") acting by its Official Liquidator Ray Jackson of KPMG, 1 Stokes Place, St. Stephen's Green, Dublin, The Republic of Ireland ("**the Irish Liquidator**" and, together with the English Liquidators, "**the Liquidators**");
- (3) **E-COM, INC.**, a Delaware corporation whose primary offices are located at Suite 502, 575 Madison Avenue, New York, New York, 10022 ("**the Assignee**");
- (4) **THE ENGLISH LIQUIDATORS** in their capacity as joint liquidators of Group Limited; and
- (5) **THE IRISH LIQUIDATOR** in his capacity as official liquidator of Ireland Limited.

RECITAL

In an agreement ("**the Sale and Purchase Agreement**") between the parties hereto dated 31 May 2000, the Assignors acting by the Liquidators, agreed to transfer certain Intellectual Property Rights to the Assignee. This Assignment is entered into pursuant to that Agreement.

IT IS HEREBY AGREED AS FOLLOWS:**1. DEFINITIONS**

- 1.1 In this Assignment, the following words shall have the meanings set out below:

“Attorneys”

means Guy William Heath, Barbara Elizabeth Cookson and Louise Philippa Gellman, each of whom are solicitors of Nabarro Nathanson of Lacon House, Theobald's Road, London WC1X 8RW, UK, and Ivor Elrifi and David Bernstein, both of whom are attorneys and partners of Mintz Levin of One Financial Center, Boston, Massachusetts 02111, USA and “Attorney” shall be construed accordingly;

“Boo.com Brand”

means the Trade Marks, the Domain Names and any and all rights relating to the “boo” brand including without limitation trade mark applications and registrations, unregistered trade mark rights and all rights or forms of protection having similar effect anywhere in the World together with any rights in all past, current and future planned website templates (including copyright, if any in the web pages, layouts, text, trade dress, look and feel, get-up, colours, logos, designs, type-faces, animations and cartoons and any draft and working documents) and any Intellectual Property Rights relating to the above;

“Domain Names”

means those domain names or applications for domain names listed in Schedule 1 hereto and any other domain names or applications for domain names in the name of or beneficially owned by any of the Group;

“Group”

means the group of companies comprising any Subsidiary of a company of which one or other of the Vendors are a Subsidiary and any Subsidiary of either Vendor to include but not limited to those companies listed at Schedule 2;

“Intellectual Property Rights”

means rights in and to patents, copyrights, database rights, designs, know-how and other similar rights (whether or not registered) in any part of the World and any rights to apply for protection or registration of such rights;

“Subsidiary”

means, in relation to any entity, any company whose ordinary share capital is owned by a proportion equal to or greater than 50% by that entity; and

“Trade Marks”

means those trade mark applications and/or registrations listed in Schedule 3 hereto.

- 1.2 In this Assignment, unless the context otherwise requires:
- 1.2.1 all references to statutory provisions or enactments shall include references to any amendment, modification or re-enactment of any such provision or enactment (whether before or after the date of this Assignment), to any previous enactment

which has been replaced or amended and to any regulation or order made under such provision or enactment; and

- 1.2.2 references to the parties, clauses and the Schedules are references respectively to the parties, clauses and the Schedules of and to this Assignment.
- 1.3 The Schedules following the operative part of this Assignment shall be deemed to be incorporated in, and form part of, this Assignment.

2. ASSIGNMENT

Pursuant to the Sale and Purchase Agreement the Assignors hereby assign to the Assignee such right, title and interest as the Assignors may have in the Boo.com Brand and any rights of action of whatsoever description in relation thereto.

3. EXCLUSIONS

- 3.1 All representations, warranties and conditions, express or implied and whether statutory or otherwise are expressly excluded (including, without limitation, warranties and covenants for or as to title of the Boo.com Brand, right to dispose, freedom from encumbrances, quiet possession, further assurance, merchantable or satisfactory quality, fitness for purpose and description) in relation to the sale of the Boo.com Brand hereunder. It is agreed by the Assignee that the provisions of this Assignment are fair and reasonable in the context of a sale of the business and assets of companies in provisional liquidation and liquidation and particularly having regard to the following matters, namely:
- 3.1.1 that the Liquidators have specifically told the Assignee that the Assignee must rely absolutely on its own opinion and/or that of its professional advisers concerning the Boo.com Brand and the quality, state and condition of the same, their fitness and/or suitability for any purpose, (which could render it inappropriate that they should be described as they are in fact described in this Assignment) or the reasons that the Assignee has or should have for purchasing the Boo.com Brand and the use to which the Assignee intends or should intend to put them;
- 3.1.2 that the Assignee has and has informed the Assignors that it has skilled professional advice available to it concerning the Boo.com Brand and the matters referred to in Clause 3.1.1 above, that it is on the basis of this advice that the Assignee has agreed to purchase the Boo.com Brand on an "as is" basis for a consideration calculated to take into account (inter alia) the risk to the Assignee represented by this Assignment, the Assignors and the Liquidators making it clear that on any other basis they would not have agreed to sell the same except for a much higher consideration; and
- 3.1.3 that the Assignee and its professional advisers have been given every opportunity it or they may wish to examine and inspect all or any of the Boo.com Brand and all or any books, records and documents relating thereto.

- 3.2 The Assignee acknowledges, for the avoidance of doubt, that if it shall be found that neither of the Assignors has title or unencumbered title to any or all of the Boo.com Brand this shall not be a ground for rescinding, avoiding or varying any or all of the provisions hereof or for the recovery of any or all of the consideration paid by the Assignee hereunder.
- 3.3 The exclusions of liability set out in this clause shall arise and continue notwithstanding the termination of the appointment of any one or more of the Liquidators before or after the signing of this Assignment and shall operate as waivers of any claims in tort as well as under the law of contract and such exclusions shall be in addition to and not in substitution for and notwithstanding any right of indemnity or relief otherwise available to the Assignors or the Liquidators.
- 3.4 The Assignee accepts and agrees that it shall be its responsibility and at its expense to apply for and obtain all necessary or appropriate licences, protection orders, legally required consents, permits and rights to use or have the benefit of the Boo.com Brand.
- 3.5 Nothing in this Assignment shall operate to restrict or affect in any way any right of the Liquidators to an indemnity or to a lien whether under section 234 of the Insolvency Act 1986 or the equivalent Irish legislation or otherwise howsoever.
- 3.6 The Liquidators are entering into and signing this Assignment as liquidators of Group Limited and Official Liquidator of Ireland Limited (as applicable) and any obligations upon them in this Assignment are agreed to solely in that capacity and they shall incur no personal liability whatsoever in respect of any matter referred to in this Assignment and, without prejudice to the generality of the foregoing, in respect of any of the obligations undertaken by the Assignors or in respect of any failure on the part of the Assignors to observe, perform or comply with any such obligations or in relation to any associated arrangements, negotiations or documents entered into by them whether such liability would arise under the Insolvency Act 1986 or the equivalent Irish legislation or otherwise howsoever.

4. POWER OF ATTORNEY

Each of the Assignors and the Liquidators (together "Donors") hereby appoint each of the Attorneys to be a true and lawful attorney for the Donors for a period of 12 months from the date of the Sale and Purchase Agreement, or in the case of the Liquidators, until they cease to be appointed as liquidators of the Assignors, whichever is earlier, and in the name of the relevant Donor to do and perform any of the acts and things to be done and performed by the Donors and, with the relevant Assignors and Liquidators' written agreement, to execute and sign any documents as shall be required for the purpose of transferring to the Assignee all of the rights referred to in Clause 2 (including, without limitation, powers of attorney appointing local trade mark agents to deal with such transfers and documents to record such transfers).

5. GOVERNING LAW AND JURISDICTION

5.1 This Assignment shall be governed by English law.

5.2 The parties accept the non-exclusive jurisdiction of the appropriate court of law in England in relation to all matters, claims and disputes arising out of in connection with this Assignment.




