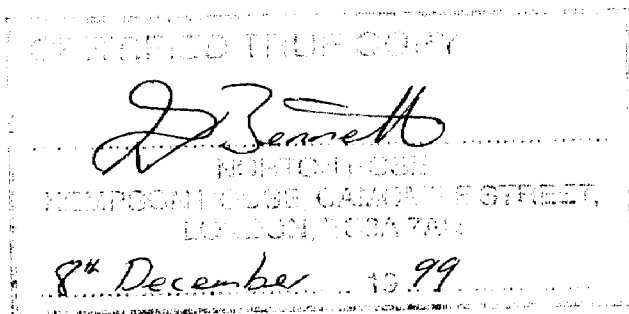

WHEREAS:

- (A) The Assignor is the registered proprietor or entitled to be registered as the proprietor of certain registered trade marks (together the "Marks") short particulars of which are set out in the Schedule hereto.
- (B) By an agreement dated 19 February 1999 between Extel Financial Limited, Financial Times Group Limited, the Assignee and Primark Corporation (the "Sale Agreement"), the Assignor has agreed, inter alia, to assign the Marks to the Assignee upon the terms set out therein and to execute this assignment.


NOW THIS DEED WITNESSETH as follows:



- 2. The rights assigned pursuant to clause 1 include the right to sue for past infringements and to retain any damages obtained as a result of such action.
- 3. At the request and cost of the Assignee, the Assignor covenants with the Assignee to do promptly all things and execute all documents as may reasonably be required to:
 - 3.1 perfect the Assignee's title in the Marks; and
 - 3.2 assist the Assignee in any claim or proceedings involving any of the Marks.


