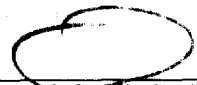

RECITALS

WHEREAS, Assignor owns, has adopted, used, intends to use and/or is using the trademarks and service marks listed on Schedule A (the "Marks"), and the patents listed on Schedule B (the "Patents") in the United States of America and corresponding foreign countries listed on Schedule C; and

WHEREAS, Assignee desires to acquire all right, title, and interest in, to and under the Marks and Patents, and all applications, registrations, and common law and analogous foreign rights therein and/or thereto, which Assignor may have or own, together with the goodwill of the businesses in connection with which the Marks and Patents are used and which is symbolized by the Marks and Patents, all other rights associated with the portion of the ongoing and existing business to which the Marks and Patents pertain, along with the right to recover for damages and profits for past infringements thereof; and

NOW THEREFORE, the parties hereto agree as follows:

1. **Assignment.** For \$10 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, and transfer to Assignee, its successors and assigns, all of its right, title, and interest, in the United States of America and all foreign countries, in, to and under, the Marks and Patents, all applications, registrations, common law rights, and any analogous foreign rights therefor, as well as the inventions described and/or claimed in the Patents in and to any reissue, renewal, continuation, continuation-in-part, continuous, divisional or reexamining applications, together with any and all of the goodwill of the business symbolized by and associated with said Trademarks and Patents, all other rights associated with the portion of the ongoing and existing business to which the Marks and Patents pertain and all income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement or misappropriation of the Marks and Patents.

2. **Miscellaneous.** Assignor hereby agrees to execute, acknowledge and deliver any and all documents as Assignee, in its sole discretion deems desirable or necessary to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Marks and Patents, and any and all goodwill associated therewith, as well as all other rights associated with the portion of the business to which the Marks and Patents pertain and that Assignor no longer has any right, title or interest, of any kind

or nature, in or to the Marks and Patents or other rights associated with the portion of the business to which the Marks and Patents pertain.

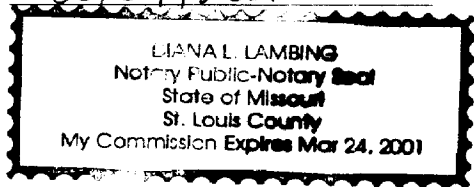
