TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), effective as of March 31, 2000 (the "Effective Date") is made by and between Texas Farm Products Holding Company (formerly known as Texas Farm Products Company), a Texas corporation ("Assignor"), and Texas Farm Products Company, Ltd., a Texas limited partnership ("Assignee").

W I T N E S S E T H:

WHEREAS, Assignor has adopted and used and in certain cases registered or applied for registration of the trademarks listed on Exhibit A to this Agreement in connection with the goods listed thereon (the "Marks"); and

2. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.

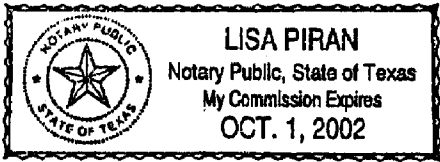

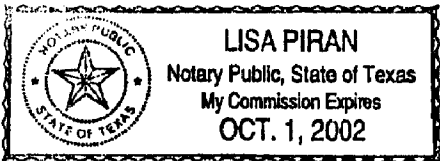
