ASSIGNMENT OF SERVICE MARKS AND TRADEMARK

WHEREAS, ME Licensing Corporation, a Florida corporation (hereinafter referred to as "Assignor"), is the record owner of the service marks and trademark as set forth in the Schedule of Marks attached hereto and made a part hereof (hereinafter collectively referred to as the "Marks"); and

WHEREAS, idEXEC, Inc., a Delaware corporation (hereinafter referred to as "Assignee"), is desirous of acquiring all of the rights, title and interest of Assignor in, to and under the Marks, together with the goodwill of the business symbolized thereby; and

Assignor authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark and service mark registrations, applications and titles thereto, to record the Marks and title thereto as the property of Assignee, its successors and assigns, in accordance with the terms of this instrument.

3. Assignor hereby sells, assigns, transfers and sets over unto Assignee, its successors and assigns, all claims for damages by reason of past infringement of the Marks, the right to sue for and collect the same of its own use and enjoyment and for the use and enjoyment of its successors and assigns; provided, however, that all claims and rights related to such losses for which Assignor has fully indemnified Assignee shall revert back to Assignor.

4. Assignor agrees to execute such further documents as may be required to record Assignee as the owner of the Marks and registrations herein assigned.
