INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (the "Agreement") is entered into as of the 9th day of November 2000 between Paging Network, Inc., a Delaware corporation (the "Lender"), and Vast Solutions, Inc., a Delaware corporation (the "Grantor").

RECITALS

A. This Agreement is being executed contemporaneously with that certain Loan Agreement between Lender and Grantor dated of even date herewith (as the same may be amended, modified or supplemented from time to time, the "Loan Agreement") and that certain Security Agreement between Lender and Grantor dated of even date herewith (as the same may be amended, modified or supplemented from time to time, the "Security Agreement"). Under the terms of the Loan Agreement, Lender has agreed to make certain advances of money and to extend certain financial accommodations to Grantor (the "Loans") in the amounts and manner set forth in the Loan Agreement. Lender is willing to make the Loans to Grantor, but only upon the condition, among others, that Grantor shall grant to Lender a security interest in, among other things, certain copyrights, trademarks and patents to secure the Obligations of Grantor under the Loan Agreement. Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Loan Agreement or, if not defined therein, the Security Agreement.

B. Grantor has adopted, used and is using (or has filed applications for the registration of) (i) the copyrights and copy rights listed on Schedule A hereto (the "Copyrights"), (ii) the trademarks, service marks, and trade names listed on Schedule B hereto (the "Trademarks"), and (iii) the (x) United States Letters Patent and the inventions described and claimed therein, and (y) the applications for Letters Patent and the inventions described and claimed therein, as set forth on Schedule C (collectively, the "Patents").

C. Under the terms of the Security Agreement, Lender is acquiring a lien on, security interest in, and license to use all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under Debtor's Intellectual Property, including the Copyrights, Trademarks, and Patents. Lender desires to have its security interest in such Copyrights, Trademarks, and Patents confirmed by a document identifying such collateral in such a form that it may be recorded in the United States Patent and Trademark Office or any other applicable office.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, as collateral security for the Obligations of Debtor under the Loan Agreement and Security Agreement, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT


To secure the prompt and complete payment and performance when due of all its Obligations under the Loan Agreement and Security Agreement, Grantor grants and pledges to Lender a security interest in all of Grantor's right, title and interest in, to and under its Intellectual Property (including without limitation the Copyrights, Patents and Trademarks), together with all goodwill of the business symbolized by the Trademarks, the right to sue for

past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof, and all proceeds of each of the foregoing (including, without limitation, all license royalties and proceeds of infringement suits).

This security interest is granted in conjunction with the security interest granted to Lender under the Loan Agreement and Security Agreement. The rights and remedies of Lender with respect to the security interest granted hereby are in addition to those set forth in the Loan Agreement and Security Agreement and the other Loan Documents, and those which are now or hereafter available to Lender as a matter of law or equity. Each right, power and remedy of Lender provided herein or in the Security Agreement or Loan Agreement or any of the Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein. The exercise by Lender of any one or more of the rights, powers or remedies provided for in this Agreement, the Loan Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Lender, of any or all other rights, powers or remedies.

IN WITNESS WHEREOF, the parties have cause this Intellectual Property Security Agreement to be duly executed by its officers thereunto duly authorized as of the first date written above.


