## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of October 11, 2000, by and between CivicBank of Commerce, having a place of business located at Oakland Main, 2101 Webster Street, 14<sup>th</sup> Floor, Oakland, California 94612 ("LENDER") and Z Co. LLC, having a place of business located at 2001 Park Place, Suite 320, Birmingham, Alabama 35203 ("OWNER") with reference to the following:

- D. For good and valuable consideration, LENDER has agreed to release its security interest in the Trademarks.



This Release of Security Interest in Trademarks shall be binding upon LENDER and its successors and assigns.
