Inso Corporation, a corporation duly organized and existing under the laws of the State of Delaware (the "Corporation"), does hereby certify that it owns all the outstanding capital stock of Inso Subsidiary, Inc., a corporation duly organized and existing under the laws of the State of Delaware, and that the Corporation, by resolutions of its Board of Directors duly adopted at a meeting of the Board on the 21st day of August, 2000 determined to merge into itself Inso Subsidiary, Inc., which resolutions were as follows:
