ASSIGNMENT OF INTELLECTUAL PROPERTY

AND, for the same consideration, Assignor does also sell, assign, and transfer to Assignee, and its successors in interest, all claims, demands and causes of action, both at law and in equity, that Assignor may have, or may hereafter acquire, on account of any infringement of the said trademarks, tradenames and service marks and the registrations thereof prior to the date hereof, and does hereby empower Assignee, and its successors in interest, to sue for and collect the same, to its and their own and absolute use;

AND, Assignor warrants that it has good and valid title to the trademarks, tradenames and service marks, including the applications and registrations therefor and shall, upon request by Assignee, execute all papers, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this Assignment at Assignee's expense and request, as well as provide such other material, information, or assistance as Assignee may consider necessary.
