INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement ("Agreement") is made by and between AFC ENTERPRISES, INC. ("Secured Party") and ULTRAFRYER SYSTEMS, INC. ("Debtor") this 15th day of June, 2000, pursuant to that certain Asset Purchase Agreement dated June 1, 2000, between Secured Party and Debtor (the "Asset Purchase Agreement"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to them in the Asset Purchase Agreement.

WHEREAS, pursuant to the Asset Purchase Agreement and that certain Intellectual Property Assignment Agreement of even date herewith between Secured Party and Debtor, Secured Party has agreed to assign and has assigned to Debtor all right, title, and interest Secured Party has in and to the Intellectual Property, including all trademarks and service marks, all registrations and pending applications (and all goodwill connected or associated therewith), and all patents and patent applications, as fully set forth in Schedule "A" hereto; and

WHEREAS, in order to secure Debtor's obligations to the Secured Party under the Note and Credit Agreement executed pursuant to the Asset Purchase Agreement, Debtor has granted to Secured Party a security interest in all of its assets, including without limitation the Intellectual Property pursuant to the Security Agreement between Secured Party and Debtor of even date herewith; and

WHEREAS, the parties desire to further confirm the security interest in the Intellectual Property granted to Secured Party pursuant to the Security Agreement;

NOW, THEREFORE, for \$10.00 and other good and valuable consideration, the sufficiency of which is hereby acknowledged, and subject to and incorporating by reference all rights and obligations set forth in the Security Agreement, the parties hereby agree as follows:

Grant of Security Interest: As security for the full payment and performance of the obligations of Debtor as set forth in the Credit Agreement and the Note, Debtor does hereby assign, transfer, grant and convey to Secured Party a first priority lien upon, security title to and a security interest in and to all of Debtor's Intellectual Property as identified in Schedule "A."

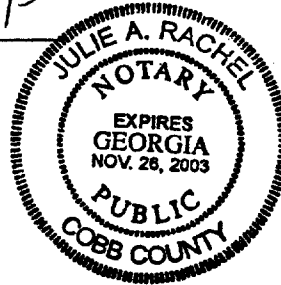

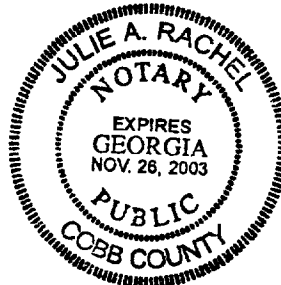
