ARTICLES OF AMENDMENT

OF

HHP ACQUISITION CORP.

To the State Corporation Commission

The following Articles of Amendment are hereby submitted pursuant to the provisions of the Virginia Stock Corporation Act on behalf of the corporation hereinafter named.
