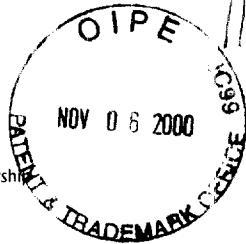

NUNC PRO TUNC ASSIGNMENT


